SUBJECT: December 1st Cut Down Procedure

The Hockey Alberta Bylaws and Regulations state:

3.7.1 Number of Players on a Hockey Team:

- b) On December 1st, all Junior teams must reduce to not more than twenty-five (25) the total of the following:
- (i) the number of registered players on their active list; and
 - (ii) the number of unused Player allotments. If twenty-five (25) players are listed, at least two (2) must be goaltenders.

All registered players not indicated on this list are considered released.

****You cannot release players to free up allotments after December 1st****

To calculate the status of your current roster:

Regular Players
 + Current Import Players (Those not released)
 + Outstanding Transfers
 = Number of actual players registered. *
 *(Does NOT include Affiliates)
