9.0 **OPERATIONS REPORT – Rob Litwinski**

Rob Litwinski presented the business plan update which included registration statistics, the Hockey Delivery Model, results from the player satisfaction survey, LMHA standards, and Hockey Alberta's key focus for the upcoming 2015-2016 season.

Rob Litwinski informed the membership there was a 10% response from all the homes the player satisfaction survey was sent to, and 90% of associations had a response. Rob Litwinski reviewed the questions in the survey and the average ranking out of 10 that each question received. Over 80% of respondents advised that they would be returning to hockey next season. Being this is the first player survey Hockey Alberta has sent out, the results will be used as a bench mark for future surveys.

Rob Litwinski reviewed the LMHA standards and noted that other branches and Hockey Canada are working on a similar document.

Rob Litwinski identified key focus items for the next season. Hockey Alberta will continue to enhance, build, and implement the hockey delivery model, review the Provincial Championship Model, build a player first charter, and review Hockey Alberta's visual identity.

A short video pertaining to the 2015 Esso Cup hosted by Red Deer MHA was shared with the membership to show a glimpse of what a national event can bring to the total community.

10.0 <u>NEW BUSINESS – Terry Engen</u>

Terry Engen advised the membership that new business was covered under the Operations Report agenda item thus there is no further new business at this time.

11.0 ELECTIONS –Rob Virgil

Terry Engen called upon Rob Virgil to conduct the elections for the Hockey Alberta Board of Directors. Rob Virgil announced the following:

Each candidate was given the opportunity to address the membership. Going in alphabetical order, John Erkelens was called upon first.

John Erkelens addressed the membership and thanked them for their support. John Erkelens spoke to a number of areas that he believes he can make a difference, including programs, association support, and management.

Rob Virgil thanked John Erkelens for his statement and called upon Jerrold Lemko to address the membership.

Jerrold Lemko presented his background and explained why he wants to be on the board. Jerrold Lemko advised the membership that being a member of the Hockey Alberta Board of Directors would be a natural progression for him and spoke of his passion for grassroots hockey. Jerrold Lemko would like to see the board a little more visible and creating relationships with the members.

Rob Virgil thanked Jerrold Lemko for his statement and went on to explain the election process.

The elections are done by secret ballot. Each member represented received an envelope at check-in for the meeting which contains the member's ballot with the vote's weight identified on the ballot. The members were advised to complete their ballot at their table, fold it in half and drop it in the ballot box at the table at the front of the room. Once all the members have voted, the ballots will be counted by Life Members and elections announced.

Rob Virgil called for any remaining ballots to be deposited into the ballot box. As all members have submitted their ballots, the election for the position of Director at Large is declared closed and the Life Members will begin to count the votes.

Based on the numbers duly recorded by the Life Members, Jerrold Lemko is declared the new Director at Large of the Hockey Alberta Board of Directors. Rob Virgil congratulated Jerrold Lemko and welcomed him to the Board.
